**RESOLUTION OF THE BOARD OF DIRECTORS OF

NUMBER 68-5820, SPECIAL TAX LEVY DUE IN FISCAL YEAR  
2024-2025**

BE IT RESOLVED by the Board of Directors of the Coachella Valley Water District assembled in regular meeting this 9<sup>th</sup> day of July, 2024, that it hereby orders the filing of Community Facilities District No. 102, Fund Number 68-5820, Special Tax Levy due in Fiscal 2024-25, in the office of the County Auditor-Controller of Riverside County, California, said list with amounts is attached hereto marked Exhibit "B".

NOW, THEREFORE, THE BOARD OF DIRECTORS OF COACHELLA VALLEY WATER DISTRICT DOES HEREBY RESOLVE, DETERMINE AND ORDER AS FOLLOWS:

1. By the Board of Directors of said District pursuant to the provisions of the Mello-Roos Community Facilities Act of 1982 (Chapter 2.5, Part 1, Division 2), there is hereby levied without regard to property valuations, special taxes on certain lands within the Community Facilities District listed on the attached schedule with reference made to Exhibit "B" to be used to apply the specific special tax within the Community Facilities District, and in not-to-exceed amounts set forth therein.
2. The Secretary of the District is hereby requested and directed to immediately and forthwith furnish and deliver a certified copy of this Resolution to the Board of Supervisors of the County of Riverside, State of California, at the County Administration Center in Riverside,
