BACKGROUND

A Special Domestic Water System Installation Agreement (Agreement) is proposed between the Coachella Valley Water District (CVWD) and the Desert Recreation District (Developer). The developer is establishing a new park named the Thermal Community Park on a 9.3-acre property located east of Olive Street and south of Church Street within the community of Thermal in Section 22, Township 6 South, Range 8 East, San Bernardino Base and Meridian. Attached please find a map of the project area and a copy of the Agreement, which has been signed by the Developer.

A summary of the Agreement with each parties' responsibilities is provided below:

- Developer to install approximately 940 linear feet of 8-inch diameter domestic water pipeline (Middleton Pressure Zone) connecting to the existing 8-inch diameter domestic water pipeline in Church Street and

heading south within Olive Street. The Developer is responsible for the costs of these facilities.

- Developer shall pay a Reservoir Fee of \$60,156 (towards 72,000 gallons of reservoir storage).
- Upon completion of the domestic water pipeline and all other requirements within the Agreement, CVWD will provide domestic water service to the park.
