**A RESOLUTION OF THE BOARD OF DIRECTORS OF  
COACHELLA VALLEY WATER DISTRICT – TRANSFER OF UNPAID IRRIGATION  
WATER AVAILABILITY CHARGES TO RIVERSIDE TAX ROLL**

*WHEREAS*, the Board of Directors of the Coachella Valley Water District on the 27<sup>th</sup> day of May, 2008, pursuant to the provisions of Sections 31031 and 31032 of the Water Code of the State of California and Section 54984 et seq. of the Government Code of the State of California, adopted Resolution No. 2008-103 invoking a water availability charge at the rate equal to 3.8 times the Irrigation Water Commodity Charge currently in effect within Improvement District No. 1 of the District; and

*WHEREAS*, on the first day of July, 2024, that being the first day of the month before the month in which the Board of Supervisors of the County is required by law to levy the amount of taxes required for County purposes, certain water availability charges, as fixed by the provisions of the above numbered resolution, remained unpaid; and

*WHEREAS*, under the provisions of the above referred to sections of the Water Code of the State of California, the amount of any unpaid water availability charges shall have a penalty of 6 percent added thereto and the unpaid balance with penalty shall be added to and become a part of the annual tax levied upon the land for which the water availability charge remains unpaid, was available and that said amount shall constitute a lien on that land; and

*WHEREAS*, Section 31032 of said Water Code directs that in the case of such unpaid water availability charge, the Board of Directors of this District not later than at least fifteen (15) days before the first day of the month in which the Board of Supervisors of the County is required by law to levy the amount of taxes required for County purposes, shall furnish in writing to said County Board of Supervisors and to the County Auditor, respectively, a description of each and every parcel of land within the District upon which a water availability charge remains unpaid together with the amount of said unpaid charges on each said parcel of land.

***BE IT FURTHER RESOLVED*** that the Board of Supervisors of Riverside County and the appropriate County Officers, acting upon the information contained in this Resolution do such things and take such actions as are required pursuant to the provisions of Sections 31031 and 31032 of the Water Code of the State of California.
