**A RESOLUTION OF THE BOARD OF DIRECTORS OF COACHELLA VALLEY
WATER DISTRICT - TRANSFER OF DOMESTIC WATER AND
SEWER AVAILABILITY CHARGES TO RIVERSIDE & IMPERIAL COUNTY TAX
ROLLS**

WHEREAS, pursuant to the provisions of Sections 31031.6, 31032.1, 31104 and 31104.6 of the Water Code of the State of California, the District Director of Service on July 9, 2024, filed with the Clerk of the Board of the Coachella Valley Water District, a written report (“Report”) for proposed domestic water; and sewage and wastewater availability assessments for all areas within the District in Riverside and Imperial Counties, to which domestic water service and/or sewage and waste service are made available by the District; and

WHEREAS, in conformity with said sections of the Water Code, the Clerk of the Board caused notice of the filing of the report, and of the time and place of the required hearing thereon, to be duly published as required by law; and affidavits of such publication have been presented and filed herein; and

WHEREAS, pursuant to Sections 31031.6, 31032.1-9, 31104 and 31104.6 of the Water Code, a public hearing was held relative to the domestic water service; and sewage and waste service availability assessments proposed to be levied by the District in the Counties of Riverside and Imperial as set forth in the Report; and

NOW, THEREFORE, BE IT RESOLVED, that the Board has heard and considered any and all objections or protests to the Report designated as Exhibit "A" containing the description of each parcel of land within said District upon which domestic water; and sewage and wastewater availability assessments will be

assessed as of the first day of July 2023, which assessments are unchanged from previous years.

BE IT FURTHER RESOLVED, that the Board hereby adopts the domestic water; and sewage and wastewater availability assessments, together with the amount in each instance and as said amount applies to each parcel of land. The Report is incorporated, approved and confirmed, and the Clerk of the Board is directed and authorized to forward a certified copy of this Resolution together with Exhibit "A" attached thereto to the Board of Supervisors and Auditors, of the Counties of Riverside and Imperial; and

BE IT FINALLY RESOLVED, that the Board of Supervisors of Riverside and Imperial Counties and the appropriate County Officers, acting upon the information contained in this Resolution, and pursuant to applicable statutes, shall take any necessary and appropriate action required pursuant to the provisions of Sections 31031.6, 31032.1-9, 31104 and 31104.6 of the Water Code of the State of California in order to have the assessments collected on the tax rolls in the same manner and at the same time as, and together with general taxes of the applicable county.
