<u>Project Location</u>: Unincorporated community of Thermal, Riverside County, in the vicinity of Airport Boulevard and Fillmore Street

<u>Project Description</u>: The Project, as modified in Addendum No 1, would construct approximately 1,400 linear feet of potable water pipeline to consolidate the De Leon Ranch small water system (SWS) (APN 763-370-026) into CVWD's existing potable water system. The Project would be located within a dirt road north of Soto Street between Soto Water SWS and De Leon Ranch SWS. Consequently, CVWD would not need to construct approximately 4,600 linear feet of pipeline within Fillmore Street and Avenue 55 to consolidate De Leon Ranch, as originally proposed in the Valley View Mobile Home Park Water Consolidation Project MND, This change results in a reduction of approximately 3,200 linear feet of pipeline from the De Leon Ranch alignment.. See Attachment A.

This Notice of Determination is to advise that the CVWD's Board of Directors approved the above-described project on July 25, 2023, and has made the following determinations regarding the above-described project:

- 1. The Project will not have any significant effect on the environment.
