#### **RECOMMENDATION:**

Approve and authorize to adopt Resolution approving the transfer of Unpaid Irrigation Water Availability charges to the Riverside County tax rolls on or before August 10, 2023.

### **BUDGET IMPACT:**

There will be a positive impact on revenues as a result of transferring unpaid accounts to the property tax roll. This results in a lien which helps ensure the District receives the money owed. As of June 21, 2023, the District anticipates transfer of approximately \$2,161,000.00 of unpaid and unsatisfied Irrigation Water Availability Assessments. The final amount will change because we allow customer payments up through July 15th each year.

### **BACKGROUND**

The District annually transfers to the Riverside County tax roll any unpaid irrigation water availability charges remaining from the previous year's assessment. This transfer must take place in order for the Unpaid Irrigation Water Availability Charges to be paid. California Code Section No. 54984.9 allows the District to determine, by resolution, that delinquent charges, plus penalty and interest, are a lien on the property and file the documents with the County Recorder's office. Please review the table below for the last three years of tax roll transfers.
