No increase is recommended for the domestic water service, sewage and waste service availability assessments in Fiscal Year 2023-2024.

## **BACKGROUND**

The Board conducts a yearly public hearing for the annual domestic water service, sewage and waste service availability assessments. The domestic water service, sewage and waste service availability assessments, funds a portion of the costs of maintaining the domestic water, sewage and waste systems.

Availability charges are based on Improvement Districts and are assessed on each acre of land or portion thereof as indicated by the table below. Parcels with applicable service during the fiscal year are considered to have satisfied the availability charges.

Availability	Improvement District	Assessed Charge
Domestic	10,13,14,15	\$ 30.00
Domestic	11	\$ 23.00
Domestic	6,7,8,18,19 and Service Area 35	\$ 10.00
Sewage and Waste Water	All	\$ 30.00
