GENERAL MANAGER RECOMMENDATION:

RECOMMENDATION:

Adopt proposed Resolutions Nos: 2023-14 and 2023-15, which will provide for the following:

- 1. Collection of funds required to meet debts service and other administrative obligations for Assessment Districts (ADs) 33, 68, and 70; and
- 2. Collection of funds required to meet maintenance, repair, replacement, and other administrative obligations for Community Facilities District (CFD) No. 102; and request the County of Riverside to levy and collect such taxes on behalf of CFD No. 102.

BUDGET IMPACT:

These special assessment levies are necessary to ensure sufficient funds are received to disburse bond payments associated with Assessment Districts 33, 68, and 70. The additional special tax levy is necessary to ensure that Community Facilities District No. 102 has sufficient funds for maintenance, repair, and replacement. These special assessments and special tax levies do not have a fiscal impact on CVWD (Coachella Valley Water District).

BACKGROUND

District staff, alongside Webb Municipal Finance, LLC, prepared the Fiscal Year 2023-2024 Special Tax Levy for CFD 102 and the assessments for the various Assessment Districts. These levies incorporate various assumptions, including:

- 1. The expected annual debt service costs of the ADs for Fiscal Year 2023-2024; and
- 2. The expected administrative costs for the ADs and CFD 102.

According to calculations, there exists outstanding 1913/1915 Act Municipal Bonds for which fixed assessments are to be levied and the Community Facilities District 102 for which special taxes are to be levied. These fixed charges for the Assessment Districts and special taxes for CFD 102 are listed under the summary schedules attached hereto (Exhibit A-Assessment Districts), (Exhibit A-Community Facilities District) and referencing Exhibits B through D.

Assessment District 33:

In 2010, the Board of Directors approved the formation of AD No. 33 for the purpose of installing irrigation pipelines to approximately 754 acres of agricultural property north of Avenue 70, west of Lincoln Street, east of Highway 86 South and south of Avenue 68. In conjunction with the Assessment District, Coachella Valley Water District (CVWD) issued bonds for \$786,528 to finance construction, formation costs, and administrative fees. The landowners that benefited from the new irrigation facilities will repay the bonds over a 30-year period. The outstanding bond prior to this levy is \$555,000.

Assessment District 68:

In 2001, the Board of Directors approved the formation of AD No. 68 for the purpose of funding certain water and sewer improvements in the Cities of La Quinta and Rancho Mirage. In conjunction with the Assessment District, CVWD issued bonds for \$2,560,000 to finance project costs, formation costs and administrative fees. The homeowners that benefited from the water and sewer improvements will repay the bonds over a 25-year period. The outstanding bond prior to this levy is \$665,000.

Assessment District 70:

In 2006, the Board of Directors approved the formation of AD No. 70 for the purpose of funding sewer improvements in the community of Thousand Palms and an unincorporated area of Riverside County. In conjunction with the Assessment District, CVWD issued bonds for \$8,239,480 to finance project costs, formation costs and administrative fees. The landowners that benefited from the sewer improvements will repay the bonds over a 20-year period. The outstanding bond prior to this levy is \$2,295,000.

Community Facilities District 102:

In 1998, the Board of Directors approved the formation of CFD No. 102 for the purpose of financing the maintenance, repair, reconstruction, and replacement of flood control facilities constructed by the owner of the property and subsequently transferred to CVWD. A special tax is levied and will continue until 2201. No bonds have been issued by this Community Facilities District.
